## ASU Law welcomes the highestcredentialed, most diverse class in its history

For the fifth year in a row, the Sandra Day O'Connor College of Law at Arizona State University welcomes a record-breaking class of students. The Juris Doctor (JD) class of 2025 comprises close to 290 students from more than 35 states and 11 countries. It is the highest credentialed to date, with a median LSAT score of 167 and a median GPA of 3.85.

ASU Law remains steadfast in its commitment to diversifying the legal field, and this year's JD class represents a record number of diverse scholars. Students of color comprise more than 35% of the class, while 20% are first-generation college students and 19% identify as LGBTQ.
